



## Vermont Rapid Response Artist Relief Application Preview

This is not the application for Vermont Rapid Response Artist Relief, but a list of the questions you'll be expected to answer in the [online grant portal](#). Character limits, when applicable, include spaces and are listed in parentheses.

### Applicant Information

Name, artist group (if applicable), artistic/creative discipline

### Proof of Artistic Practice

You will only need to provide one form of proof: either an artist résumé, a work sample, or a website featuring your artistic work.

### Impact and Relief

This fund is open for artists who have experienced cancelled gigs or loss of supplemental income. You do not need to have experienced both.

If you had a scheduled gig or opportunity (e.g., commissions, performances, contracts, workshops, classes, etc.) cancelled due to COVID-19 or had to cancel because you are an immune-compromised person, then you will need to provide the following information:

- date of cancelled event
- presenter/venue
- upload proof of gig (Please provide as much detailed documentation as you can about this gig. You can only upload PDF or JPEG files.)
- if needed, provide clarification or details about your upload (250 characters)
- amount of income lost due to cancellation of this event and if that amount is confirmed or an estimate

You can provide information for up to three cancelled gigs or opportunities.

If you lost full or part-time supplemental income used to support your creative practices, then you will need to provide the following information (this includes artists and craftspeople who have lost income from the closure of galleries):

- date of job loss or gallery closure
- briefly describe your job (500 characters)
- upload proof of job loss (Please provide as much detailed documentation as you can about this job loss. You can only upload PDF or JPEG files.)
- if needed, provide clarification or details about your upload (250 characters)
- amount of income lost due to job loss (How much would you typically earn in a month?)

### **Impact and Relief (continued)**

Describe how the loss of income impacts your situation. Please note that this emergency funding is intended for urgent needs. (1,000 characters)

How much are you requesting? Grants can be up to \$500. Please remember that funds are limited and need to support as many artists as possible. (4 characters)

If needed, provide any information we have not requested, but which you feel is important in evaluating your application. (500 characters)

### **Agreements**

You will need to agree to the following statements and conditions:

- all elements of your application are true
- you certify that you have been a Vermont resident for one year and will be a resident upon approval of a grant
- you certify that you are eighteen years of age or older
- you understand that your application is subject to approval by Vermont Arts Council and available funding
- if awarded funding, you will be required to submit an ACH direct deposit form to receive grant funds. To protect your sensitive information, we securely encrypt notification emails through Barracuda Networks Message System

Please confirm that your contact information in your SlideRoom profile is accurate before submitting your application. The address must be your Vermont mailing address. We will use the email provided to notify you of an award.
