



## Vermont Economic Recovery Grant for Cultural Organizations Supplemental Grant | Application Preview

### Required Information

You will need the following documents and information to complete your application:

- application number from your original ACCD grant proposal
- Federal Tax ID Number (or EIN)
- the amounts of previous compensation (if any) you have received to cover business interruptions due to COVID-19
- income statements for 2019 and 2020 to date (see [requirements in the guidelines](#))

### Organization Information

Provide the name of the organization (exactly as shown on your IRS 990 form) and the name, email address, and phone number of the primary contact.

Provide the application number from your original ACCD grant and the total amount of funds already granted to you from the ACCD Vermont Economic Recovery Grant program.

Provide your organization's 2019 total eligible revenue. (Please note that eligible revenue formulas have expanded from the original application. This number needs to be verifiable from the attached income statements. Please [refer to the guidelines](#) for income statement requirements and eligible revenue instructions.)

### Eligibility

Compared to the same calendar month or three-month period in 2019, has your organization experienced a greater than 50% loss of eligible revenue between March 1 and September 1, 2020?

Provide the maximum number of employees you had at any point between January 1, 2019 and today.

Provide the month or three-month period when eligible revenue declined.

Provide the eligible revenue from the period in 2019.

Provide the eligible revenue from the same period in 2020.

## Benefit Information

Has your organization received compensation from an insurance company for the covered business interruption due to COVID-19? If yes, provide the amount.

Has your organization received a SBA backed Payroll Protection Program (PPP) loan? If yes, provide the amount.

Has your organization received an Economic Injury Disaster (EIDL) grant? If yes, provide the amount.

Has your organization received any other grants or non-loan compensation from any other Federal programs for damages incurred due to COVID-19? If yes, provide the amounts.

## Emergency Funding

Provide the dollar amount for the total financial loss to date for your organization from COVID-19.

If you can project future losses for the rest of the calendar year, please provide a dollar amount.

(Optional) Provide any explanation for the two numbers provided above. (2,000)

How have your typical sources of revenue been impacted by COVID-19? (2,000)

Please explain your current and continuing fixed costs (salaries of retained staff, rent, utilities, etc.) (2,000)

(Optional) If needed, you can provide any information we have not requested, but which you feel is important in evaluating your application. (3,300)
